

On the impossibility of fair risk allocation

Abstract

We show that by using a coherent measure of risk it is impossible to allocate risk satisfying the natural requirements of (Shapley) Core Compatibility, Pareto Optimality, Equal Treatment Property and Strong Monotonicity. To obtain the result we characterize the Shapley value on the class of totally balanced games and also on the class of exact games.
